Public Hearing/Adoption of Resolution 2015-06 Proposed Millage Rate

• Verification of Public Notice

• Presentation of Proposed Millage Rate/Procedures

Chief Gorski gave an overview of the millage rate. The 2015/2016 operating millage rate recommendation is 1.2061 mills.
