OLD BUSINESS

* Station 4 remodel

DC Perry gave an update on the station 4 remodel. The Board was shown pictures of the current condition of the station.

* Sale of E12

Captain Chevalier: The leaks on the pump were repaired and passed testing. Documentation was sent to Brindlee Mountain showing the repairs were made and to contract to purchase at \$120,000. Brindlee Mountain counteroffer at \$120k.

Commissioner Grote motioned to sale E12 for \$120,000 to Brindlee Mountain. Commissioner Center seconded the motion and the motion unanimously carried.

1. FY 2025 draft budget

Chief Bounds presented the Board copies of the latest draft version of the budget. Commissioner Center had questions regarding the changes in the budget.

2. DR 420 Preliminary

The Board reviewed the DR 420 MMP.

* Pension – Capt. Chevalier

At the 07/09/24 pension meeting, the pension board got legal clarification on volunteer time and if it affects the 5-year retirement/DROP period. The Pension Board will draft up language clarifying the volunteer time does not affect the 5-year retirement/DROP period. The union will have a meeting to discuss removing the 5-year period. The Pension Board would like to request an actuary study on adding a COLA to the FF pension plan. Capt. Chevalier will get cost of the study and present it to the Board for approval.

* Union Report

FF. Keusch: Biden passed a law expanding the Assistance to Firefighter Grant and SAFER grant.

CHIEF'S REPORT

Chief Bounds: Updated the Board on the training incident at Station 1. Insurance claim was made and an adjuster has been scheduled out to the business.

Inspector Segnari: October is fire prevention month and the topic is fire alarms. Open house is scheduled for October 12, 2024. Fire prevention has been working with Manatee County to enforce the usage of lithium batteries and paint booths.

DC Perry: The damages from the lighting strike at station 3 have been repaired except for the circuit board for the generator. Ten 8 is opening a facility in Georgia that will only sell refurbished fire engines. Active shooter policy has been created.

Chairperson Marken called for Public Comment and there was none.
