\* Station 4 remodel – Magnum Builders presentation

The Board agreed with the suggested changes made by administration. The Board approved Magnum Builders to proceed with renovating station 4 with the revised GMP and price increase.

# \* Union Report

### **CHIEF'S REPORT**

Chief Bounds: Made four job offers to potential new employees. SMFR and other fire districts will be meeting to discuss consolidation of the fire districts, presented by Manatee County Board of Commissioners.

Deputy Fire Marshall Meola: Applied for a grant for smoke detectors.

Cpt. Bloski: The Governor is looking at funding special teams (Hazmat, TRT, Marine) throughout the state.

EMS Officer Wernet: We passed our ALS inspection.
